

## ORDINANCE #602 TOWN OF WILBUR 2022 BUDGET

An ordinance adopting the budget for the Town of Wilbur, Washington, for the fiscal year ending <u>December 31, 2022</u>.

WHEREAS, the mayor of the Town of Wilbur, Washington completed and placed on file with the town clerk a proposed budget and estimate of the amount of the moneys required to meet the public expenses, bond retirement and interest, reserve funds and expenses of government of said town for the fiscal year ending December 31, 2022, and a notice was published that the council of said town would meet on the 16<sup>th</sup> day of November, 2021 at the hour of 7:00 p.m., at Town Hall of said town for the purpose of making and adopting a budget for said fiscal year and giving taxpayers within the limits of said town an opportunity to be heard upon said budget; and

WHEREAS, the said Town Council did meet at said time and place and did then consider the matter of said proposed budget; and

WHEREAS, the said proposed budget does not exceed the lawful limit of taxation allowed by law to be levied on the property within the Town of Wilbur for the purposes set forth in said budget, and the estimated expenditures set forth in said budget being all necessary to carry on the government of said town for said year and being sufficient to meet the various needs of said town during said period.

NOW, THEREFORE, the Town Council of the Town of Wilbur do ordain as follows:

<u>Section 1</u>. The budget for the Town of Wilbur, Washington, for the year <u>2022</u> is hereby adopted at the fund level in its final form and content as set forth in the document entitled <u>2022 Budget</u> three copies of which are on file in the Office of the Clerk.

<u>Section 2.</u> Estimated resources for each separate fund of the Town of Wilbur, and aggregate expenditures for all such funds for the year <u>2022</u> are set forth in a summary form below and are hereby appropriated for expenditure at the fund level during the year <u>2022</u> as set forth in the <u>2022 Budget</u>.
