BUDGET MEETING

Opened at 6:00pm - Discussion on Capital Facilities Plan, updated the project list and listed projects according to need. Discussed the option to pay off sewer loan early so that a loan can be started for the water main project on Knox Street next to the senior center as we may not be able to secure a grant for the third year in a row. CDBG would like to see the Town secure a loan to show financial need for their grant which would go to the overall debt. CONSENT AGENDA

Citizen comments - Sara Rice, wanted to discuss the pickleball court.

NEW BUSINESS

Officer Cuzzetto and a new hire from Spokane Officer Rose were present to read the July Stats. Officer Cuzzetto asked for a copy of the compression brakes ordinance to enforce the fine, Melissa will get a copy to him.

Sunrise Disposal, rate increase and contract - The owner Dion Gotti, joined the meeting via zoom to address the need for the eight percent cost of living increase that would be effective October 1st. Council is approving of the request. Mr. Gotti had a handout for the Mayor and Council to look over regarding recent purchases and upcoming purchases to improve service in our area. Recycling was discussed and rates will be sent to the Town Clerk. Mr. Gotti stated that the recent increase to rate could be set for 2023 going into the new contract that will begin in May of 2023. Further negotiations for the new contract will take place in January 2023.

Basketball Court - Melissa advised that quotes have been requested and Courtney is doing research to find all the correct specifications. More to come later.

An updated engineer project list was handed out.

A copy of the Foreman's July report was handed out.

OLD BUSINESS

New Airport Hangar Lease - Lynn McWhorter stated that she had read over the new lease thoroughly and is not in agreement with sections of the lease and will not approve it as is. The Airport Board Members will be invited to a future council meeting to discuss the lease before it is approved.
