### **CONSENT AGENDA**

Joel Krause made a motion to approve the following.

#### **NEW BUSINESS**

No LCSO representative was at the meeting, so the stats were tabled.

Kevin Leyva, Wilbur Airport Manager and Dean Dreger Airport Board member were present to discuss questions from Council regarding the new hangar lease. After a short discussion and clearing up some confusion, Lynn McWhorter made a motion to approve the lease as written, John Hanon seconded, all approved.

Wilbur High School seniors, Hunter Sanderlin and Ashleigh Knauer were present to ask council to approve the Ag Days events for this Saturday, October 8th including street closures for the parade on Front Street. Council approved all events.

New main street banners - representative was not at meeting, tabled until next meeting.

Festival of lights donation - tabled.

EMT training mileage reimbursement - Council discussed reimbursing new trainees who travel for the classes for fuel. Melissa had discussed the option of using units of pay that is used for regular ambulance runs with Phin Haglin, EMT Captain. Council is in approval of this plan.

New utility forms - Mayor Hearrean explained the need to have forms that are used for utility services. Melissa went over three forms. The first is for any title company to fill out and request a final utility bill before a

property sale is complete, the second is for landlords to verify and consent for services for their tenants and the third is for all new residents to start utility services.

New Nuisance Director - Tim Rogers was announced as the Nuisance Director, his first day was on September 26th, he will be part time and is already jumping into tasks. Council requests his presence at the next meeting to go over priority items.

Basketball Court - looking for fundraising ideas. More to come later.

#### **OLD BUSINESS**

Surplus List- A new surplus list was created with five items. Council discussed each and will come up with a minimum sale amount for each.

#### RESOLUTION/ORDINANCE

Ordinance 606 - Lynn McWhorter made a motion to approve ordinance 606 amending the Town garbage rates as written, Roy Scheibner seconded the motion, all approved. Ordinance passed.

Ordinance 605 - This ordinance was revisited due to changes by the town attorney. Joel Krause made a motion to approve Ordinance 605 as written, Adopting Title 4, Town Purchasing and surplus of property; Lynn McWhorter seconded; all approved. Ordinance passed.

Resolution 541 - Roy Scheibner made a motion to approve Resolution 541 as written adopting the levy rate for 2023; Lynn McWhorter seconded; all approved. Resolution passed.
