BUDGET MEETING

Opened at 6:00pm, discussed budget amendments for 2022, 2023 Final budget adjustments, and EMT Pay. Budget meeting closed at 6:42pm.

REGULAR COUNCIL MEETING CALL TO ORDER

CONSENT AGENDA

Lynn McWhorter made a motion to approve the following.

Payroll check's 26281 - 26307 in the amount of \$41,076.87 dated October 31, 2022.

Accounts Payable check's 26308-26321 in the amount of \$95,461.07 dated November 1, 2022.

Approval of minutes from October 18, 2022, for regular council session.

REGULAR SESSION

Citizen comments - Fred and Sabine Rosman explained the history of the trees on Main street, he wanted to ask about other options to keep from cutting down the one tree issue in front of the parts store. The Mayor and Council advised that the tree issue would not be resolved before spring, and they are open to options.

Rick Jones was present to address the concerns regarding the remodel at the community center.

NEW BUSINESS

Community Pride Month Ideas - Melissa Bulger, proposed the idea of having a community clean up month in April, with each week having a focused idea on how to help the community look its best. These ideas include the regular appliance pickup and free brush pile days. New ideas of having a wrecker to remove junk vehicles and having an additional pick up for larger garbage items such as old furniture etc. This helps those residents who would like to clean up but do not have the means to do so.

Foreman's Report October - a copy of the report was given to council.

Free Brush Pile Days - Tabled until next meeting.

National Flood Insurance/Department of Ecology Visit - Melissa advised and presented council with an email regarding an upcoming visit from NFIP and the Department of Ecology. It is scheduled for December 7th for anyone who wants to join.

New Avista Lights Request - John Hanon stated that he was asked about having a new streetlight installed next to the Senior Center. Melissa will contact Avista to get a price quote for the request and another residential request.

OLD BUSINESS

Main Street Tree Removal - tabled for alternative ideas for the one tree with the walkway issue in front of the parts store.

RESOLUTION/ORDINANCE

Ordinance 607 – Establishing utility account guidelines for residential and commercial accounts. Lynn McWhorter made a motion to approve ordinance 607 as written, John Hanon seconded; all approved. Ordinance passes.

Resolution 543 - Lynn McWhorter made a motion to approve resolution 543 as written, establishing new utility account deposit rates; John Hanon seconded; all approved. Resolution passed.

DONATIONS

\$10,000.00 donation from the Tuft's Foundation to help install a new basketball court. \$44,00 from the ORV Park donation box.

Mayor Hearrean spoke about the recent Mayor's Meeting with the EDC and the upcoming airport meeting on November 7th at 10am.
