REGULAR COUNCIL MEETING CALL TO ORDER

CONSENT AGENDA

John Hanon made a motion to approve the following. Payroll check's 26544 – 26552 in the amount of \$12,110.34 dated March 13, 2023. REGULAR SESSION

NEW BUSINESS

Mayor Hearrean advised of the executive session that will take place at the end of the regular meeting regarding the pending lawsuit.

David Bjorson read the February foreman's report.

David Bjorson and Melissa Bulger advised Council the need for a new water meter system. Pricing to be discussed at a future meeting. Money allocated for water main in reserves might be an option to cover the cost.

Cannabis Zoning – Melissa spoke about changes in Washington State Legislature and the need to address zoning for cannabis producers, processors and retailers is necessary. There are state laws that address some areas in town but we as a community need to decide specifics. If the Town decides to prohibit all cannabis then we will be ineligible for the revenue share that we currently see from the State. There were a couple of questions from council that Melissa will get answers to for the next meeting.

Year End Report – Melissa handed out copies of the year end report and advised council that they need to read it thoroughly before the next meeting and will be asked to sign an acknowledgement form.

Public Works shed – David asked council what the price cap would be on a storage shed. He explained the size and description of what he is needing for all the small equipment that has been purchased. Council agreed to capping the spending at \$9,000.

Avista Main Street Light Poles - David explained his meeting with Avista earlier in the day. He asked council if they are ok with a few of the new poles to be placed in the current bulb outs. Council asked if this would cause

any changes to the sidewalk, the answer is no. Council is ok with the placement. Construction should start soon.

OLD BUSINESS

Sunrise Garbage Contract - Melissa, Lynn and John had a meeting with Sunrise to answer any questions or concerns. Melissa received a couple of sample contracts from Sunrise to go over before the next meeting. Also waiting on new contract option from Sunshine.

Summer Help – We have received one application and there are possibly two or three more coming in. Lynn and Nichole volunteered to help with the interviews.
