#### REGULAR COUNCIL MEETING

#### CALL TO ORDER

#### **CONSENT AGENDA**

Lynn McWhorter made a motion to approve the following:

Payroll checks 27258 - 27270 in the amount of \$17,837.62 dated January 29, 2024.

Approval of minutes from January 16, 2024 for regular council session.

#### **REGULAR SESSION**

Citizen comments - Heather Bowen suggested fundraiser ideas for the ambulance fund and inquired about the appeal process. Mayor explained the steps and potential timeline for the appeal. EMT Cpt Phin Haglin thanked her for the T-shirt sales idea.

#### **NEW BUSINESS**

Deputy Wardlaw read the Sheriff's report: 44 incidents in January, including a fireworks issue.

Lincoln Co. Solid Waste Advisory Committee: Mayor asked if any Councilmembers were interested in joining. John said he was seriously considering it.

Bridge Work: letter in Council books. Council clarified which bridges need work. Tabled.

Court of Appeals: Mayor mentioned appeals letter and update on case. Letter copy in council packets.

Playground Equipment Committee: Council discussed when it will begin meeting and who will be on it.

#### **OLD BUSINESS**

Building Inspector: Joel inquired about the status. Courtney reported that Mike Pasmore was hired.

LCSO Contract: Mayor reassured council that rates not going up. Letter sent in error.

Pool: Nothing new

Town Insurance: Council discussed the denial for an extension on cancellation deadline.

USDA Loan/Grant: Council agreed that a shed or building for the Public Works equipment was good idea to protect from the elements; discussed other options.

Fiber Build Update: the estimate for work being completed was pushed out a month due to pole work with Avista; Mayor said to expect end of March.
